# TERMS & CONDITIONS

Please read the following information, then sign and date on the next page.

1. GENERAL: Please leave the studio as you found it.
2. ARRIVAL TIME: Set up is 15 minutes before the party start time.
3. FLOOR: Please be careful when walking or dancing on the dance floor in the Studios (dance flooring is really expensive and can tear easily!). Do not wear high heels on the floor and make sure that you have not got stones in your shoes. Any permanent marks or tears will have to be charged for.
4. STEREO: The stereos are available for use, but please have consideration for others in the surrounding area and keep the volume at a sensible level.
5. KITCHEN: Feel free to use our kitchen facilities and please wash up after yourself. Please do not eat food on the dance floor and please throw away any rubbish in the bins.
6. INSURANCE: You will be responsible for your own health and safety. If you see any problem in the studio which could cause an accident, then you must report it immediately. If you have an accident on the premises, then please report it to Move It Dance immediately, and/or fill in the Accident Book. Move It Dance accepts no responsibility for injuries caused. There are First Aid kits located on both floors.
7. PERSONAL BELONGINGS: Move It Dance accepts no responsibility for personal belongings. You will be responsible for your own belongings. Make sure that you take them with you at the end of the party.
8. TOILET: There is a toilet upstairs for use.
9. LEAVING THE STUDIO: Please make sure all plug sockets, lights, heaters have been switched off and all windows closed before you leave. If any of the leaving procedures are not completed after your hire, this could result in an additional charge.(e.g. if lights are left on overnight, or windows left open and it rains).
10. PAYMENT: Payment by cash, cheque or standing order. Deposit of £50 must be made at time of booking, with the remaining balance to be paid on the day of the party. Please make cheques payable to Move It Dance Limited.
11. FIRE SAFETY: If the alarm goes off, please leave the studio and meet at the Fire Assembly Point.
12. DAMAGES: If you damage anything in the studio then you will be liable to pay for the repair costs.
